BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF POPE, STATE OF ARKANSAS; AN ORDINANCE TO BE ENTITLED: "AN ORDINANCE APPROPRIATING AND LEVYING MILLAGE TAXES ON ALL PROPERTY IN POPE COUNTY, ARKANSAS, FOR THE YEAR 2023 TO BE COLLECTED 2024; AND FOR OTHER PURPOSES".

BE IT ORDAINED BY THE QUORUM COURT OF POPE COUNTY:
